

## Event Cinemas Movie Ticket Promotion Terms and Conditions.

1. Participation in this Event Cinemas movie ticket promotion is deemed acceptance of these Terms and Conditions.
2. The Promoter of this Event Cinemas movie ticket promotion is Dulux Rewards, [duluxrewards.com.au](http://duluxrewards.com.au).
3. To claim 2 Events Cinemas adult movie tickets, you must redeem 100,000 points or more via the Dulux Rewards website at [duluxrewards.com.au](http://duluxrewards.com.au) (excluding gift cards and travel redemptions) during the promotion period (each redemption constituting an 'Eligible Transaction').
4. The promotion period is 15<sup>th</sup> July to 31<sup>st</sup> August 2019.
5. We will automatically calculate the number of Events Cinemas adult movie tickets you are eligible to claim according to the qualifying redemptions redeemed during the promotional period (excluding gift cards and travel redemptions). Depending on your qualifying redemptions (excluding gift cards and travel redemptions) during the promotion period a member may therefore be eligible to more than 2 movie tickets up to a maximum of 4 movie tickets from 2 Eligible Transactions.
6. If you have made an Eligible Transaction, we will send you an email (to the email address registered to your account) to notify you at the end of the promotion period.
7. Your movie tickets will be sent to you between 1<sup>st</sup> and 31<sup>st</sup> August 2019. As your movie tickets will be sent to your registered address, please ensure your primary account name and address is up to date.
8. Lost tickets will not be replaced and have no transferable value.
9. Film classification rules apply to use of movie tickets. Restrictions apply, including not valid for movies on Saturdays after 5pm and valid for regular (i.e. non-3D movies only). Please refer to the movie ticket terms and conditions printed on the reverse of each movie ticket for the full terms and conditions.
10. The movie tickets are valid for 3 months from 1 August 2019 to 31 October 2019.
11. Personal identification and proof of age may be required to obtain tickets for certain cinema movie sessions.

11. The Promoter may refuse to allocate any movie tickets in the event any participant engages in conduct in relation to this Promotion which is misleading, deceptive, fraudulent or damaging to the Promoter's goodwill or reputation.
